PA CARE Package

Attorney General Josh Shapiro is announcing the launch of 'PA CARE Package', Pennsylvania's consumer relief initiative.

To commit to the 'PA CARE Package' initiative, financial institutions and banks must offer additional assistance to Pennsylvanians facing financial hardships due to impacts of the pandemic.

- Expansion of small and medium business loan availability
- 90-day grace period for mortgages (at least)
- 90-day grace period for other consumer loans such as auto loans
- 90-day window for relief from fees and charges such as late, overdraft fees
- Foreclosure, eviction, or motor vehicle repossession moratorium for 60 days

<u>Unemployment Compensation</u>

Pennsylvania is waiving the Work Search and Work Registration requirements and suspending the one-week waiting period if your employer temporarily closes, reduces your hours, or if you have been told to self-isolate.

Pennsylvania COVID-19 Working Capital Access Program (CWCA)

The COVID-19 Working Capital Access (CWCA) Program is administered by the Pennsylvania Industrial Development Authority (PIDA) and provides critical working capital financing to small businesses located within the Commonwealth that are adversely impacted by the COVID-19 outbreak.

Loans of up to \$100,000 can be requested, with a 12-year amortization with no payments due during the first year.

<u>US Representative Conor Lamb Answers COVID-19 Frequently Asked Questions</u>

In response to the coronavirus pandemic, Congress recently passed H.R. 748, the bipartisan Coronavirus Aid, Relief, and Economic Security (CARES) Act. This critical \$2 trillion spending package includes provisions to support families and workers, small businesses, state and local organizations and health care workers and hospitals. Previously, Congress passed two bipartisan measures – H.R. 6201, the Families First Coronavirus Response Act and H.R. 6074, the Coronavirus Preparedness and Response Supplemental Appropriations Act – to address the impact of the coronavirus.
