Solicitor Mike Jones stated that Ordinance 2021-01 was advertised in the Beaver County Times on 8/20/21, Ordinance 2021-01, establishing the Hopewell Township Volunteer Fire Company's Authority to impose fees and recover from third party insurance the reasonable costs associated with Firefighting materials, equipment and hazardous abatement materials, involving any hazardous material incidents, environmental incidents, safety and rescue incidents, firefighting incidents, and vehicular accidents.

Fire Chief, Mike Wasik confirmed that the Fire Department is not using this as way to supplement their budget but to absorb costs that are associated with services.
