

# HOPEWELL TOWNSHIP ORDINANCE 2017-02

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, APPROPRIATING MONIES FROM MUNICIPAL TAXES AND REVENUES TO DEFRAY EXPENSES AND LIABILITIES OF HOPEWELL TOWNSHIP FOR THE FISCAL YEAR ENDING DECEMBER 31, 2018

**BE IT ORDAINED AND ENACTED**, and it is hereby ordained and enacted by the Board of Commissioners of the Township of Hopewell, Beaver County, Pennsylvania, and it is hereby ordained and enacted according to the power and authority granted under the First Class Township Code, Act of December 14<sup>th</sup>, 1967, P.L. 819, effective January 1<sup>st</sup>, 1969.

SECTION 1. That the following sums of money, or as much therefore as may be authorized by law, as may be needed or deemed necessary to defray all expenses and liabilities of Hopewell Township, be and the same hereby are appropriated for the purposes and objects of said Hopewell Township hereinafter specified for fiscal year commencing on the first day of January, 2018 and ending the thirty-first day of December, 2018.

Solicitor Mike Jones announced that the Board of Commissioners would receive the recommendation on the Blake Meehan request from the Hopewell Township Planning Commission. At the conditional use hearing that took place back in October/November of this year, the BOC asked that the Planning Commission review the conditional use request. At the December 18<sup>th</sup>, 2017 Planning Commission meeting, the Hopewell Township Planning Commission recommended approval of the conditional use request, with four considerations:

- 1. That a buffer be established, where deemed appropriate, to protect adjacent properties from airborne pollutants.
- 2. That hours of operation be designated so as not to disturb the peace & quiet of the Valleyview Neighborhood.
- 3. That any stormwater concerns be addressed at the site.
- 4. That any building construction and site improvements be aesthetically harmonious with the Valleyview Neighborhood.

Solicitor Jones then announced that the Board of Commissioners can close the record on the conditional use request and officially close the hearing. The BOC has 45 days to accept the Planning Commission recommendation or make other recommendations to the conditional use request. President Bufalini said the BOC would review the request at the January 8, 2018 workshop meeting.
