#### **ORDINANCE 2012-08**

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, FIXING THE TAX RATES TO BE REQUIRED TO DEFRAY SPECIFIC EXPENDITURES AND LIABILITIES FOR THE OPERATION OF THE TOWNSHIP GOVERNMENT FOR THE YEAR ENDING DECEMBER 31, 2013.

**BE IT ORDAINED AND ENACTED,** by the Board of Commissioners of the Township of Hopewell, Beaver County, Pennsylvania, a Municipal Corporation under the First Class Township Code of the Commonwealth of Pennsylvania.

SECTION 1. That for and during the 2013 calendar year, a tax be and is hereby levied on all property within said Township of Hopewell, subject to taxation for Township purposes at the rate of FOURTEEN mills of each dollar, or the sum of one dollar and forty cents (\$1.40) on each hundred dollars, of assessed valuation.

SECTION 2. That the collection period shall be two percent (2%) <u>Discount</u> from March First through April Thirtieth; <u>Face</u> from May First through June Thirtieth, and <u>Penalty</u> of ten percent (10%) assessed after June Thirtieth.

SECTION 3. That the estimated expenses of Township government and the amounts appropriated therefore from the revenue estimated to be derived during the calendar year ending December 31<sup>st</sup>, 2013 are fully set forth in the adopted Budget of the Township, a copy of which is on file in the office of the Township Manager, at the Municipal Building, 1700 Clark Boulevard, Aliquippa PA 15001.
