Michael Jones opened a public hearing to discuss Ordinance 2022-02 Timber Harvesting. The amendment to O2011-05 addresses section 4 dealing with general operation requirements. One adds language requiring that all trees to be harvested should be properly marked with tree marking paint at eye level, on two sides of the tree, and also below stump height. Upon the discovery of unmarked stumps, the Township may immediately cease operations. The other adds section R to that same part of the ordinance that prohibits portable sawmills at logging or timber harvesting operations sites.

This change was advertised in the Beaver County Times on June the 7th. Mr. Jones asked for any public comments to the amendments.

Michael Michalo, 1019 Crissman Dr., Hopewell Township PA

Mr. Michalko stated he disagreed with section R, prohibiting portable sawmills from the site. He feels that should be a choice of the property owner if they are using it for themselves.

Mr. Jones discussed the concern did not lie within personal use of portable sawmills but with commercial use.

Zoning Officer John Bates confirmed that past commercial timber harvesting in the Township has resulted in large scrap piles of debris left onsite.

Mr. Jones discussed that if it were to be used exclusively by the owner of the property it would be allowed and they would be able to amend the Ordinance to reflect that minor change.

The hearing was closed at 7:15 P. M.

Mr. Jones will draft language to reflect the amendment discussed and the vote will move forward.
