ORDINANCE NO. 56-2

AN ORDINANCE TO ESTABLISH THE PLACE OF THE ORGANIZATION AND TO ESTABLISH THE DATE, TIME AND PLACE OF THE REGULAR MONTHLY MEETINGS OF THE TOWNSHIP OF HOPEWELL BOARD OF COMMISSIONERS.

Be it ordained and enacted and it is hereby ordained and enacted as follows:

Section I. The organization meeting in the even numbered years shall be held at the Hopewell Township Municipal Building, Clark Boulevard, Aliquippa, Pennsylvania at the time and date designated by law from time to time.

Section II. In accordance with the First Class Township Code the Board of Commissioners of the Township of Hopewell shall meet regularly on the first Monday of each and every month at 8:00 o'clock, P.M., E.S.T. and E.D.S.T. when D.S.T. is in effect, at the Hopewell Township Municipal Building, Clark Boulevard, Aliquippa, Pennsylvania.

Section III. All ordinances, resolutions or motions heretofore adopted and enacted inconsistent herewith are hereby repealed.

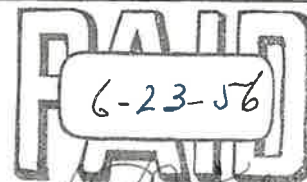
