ORDINANCE NO. 57-8

AN ORDINANCE AMENDING THE ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA PROVIDING FOR THE LEVY AND COLLECTION OF A TAX OF \$2.00 PER MONTH OR FRACTIONAL PART THEREOF ON THE USE OR OCCUPATION OF HOUSE TRAILERS SUITABLE FOR LIVING QUARTERS AND PRESCRIBING PENALTIES UNDER THE AUTHORITY OF ACT OF JUNE 25, 1947, P.L. 1145 AND ITS AMENDMENTS.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania, under the authority of the Act of June 25, 1947, P.L. 1145 and its amendments, and it is hereby enacted and ordained by authority of the same:

SECTION 2. Said tax shall be collected monthly by the Tax Collector of the Township of Hopewell from the owners of any such house trailers in said Township. Said Section 2 is hereby amended to read as follows:

SECTION 2. Said tax shall be collected either monthly or yearly in advance at the discount rate of Twenty (\$20.00) Dollars per year by the Tax collector of the Township of Hopewell from the owners of any such house trailers in said Township.
