ORDINANCE NO. 69-6

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER
COUNTY, PENNSYLVANIA AMENDING SECTION III OF ORDINANCE
NO. 59-4.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of
Hopewell Township, Beaver County, Pennsylvania and it is hereby
enacted and ordained by authority of the same as follows:

1. That Section III of Ordinance No. 59-4 is hereby amended
to read as follows:

"In the event that it is necessary for the Township Sewer
Inspector to make more than one trip to the site of an excavation
to inspect same, the excavator shall be obligated to pay to
Hopewell Township a fee of \$5.00 for each additional trip so made."

2. All ordinances or parts of ordinances conflicting with
the provisions of this ordinance are hereby repealed to the extent
of such conflict.
