

ORDINANCE NO. 42-5

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL,
BEAVER COUNTY, PENNSYLVANIA, ESTABLISHING
FEES FOR THE ISSUANCE OF PERMITS FOR THE
CONSTRUCTION, ERECTION AND EXTERIOR RENO-
VATION OF STRUCTURES

BE IT ORDAINED by the Board of Commissioners of the
TOWNSHIP OF HOPEWELL, a municipal corporation situate in the
County of Beaver and Commonwealth of Pennsylvania, and IT IS
HEREBY ORDAINED:

SECTION 1. That the fees appearing in the following
tables are hereby adopted as the fees for the issuance of a
permit for construction, erection and exterior renovation of
structures exceeding a capital value of One Hundred Dollars
(\$100.00):

SECTION 2. That "structures" shall be deemed to include, without limitation, self-supporting or free-standing signs designed for commercial advertising or business identification. The following signs, however, shall be exempt from the provisions of this ordinance:

- (a) signs advertising the sale or rental of property;
- (b) political signs;
- (c) signs erected by governmental agencies;
- (d) signs erected by non-profit charitable, educational or religious agencies, if erected upon premises owned by such agency.

SECTION 3. It is hereby declared that the intent of this Schedule is to defray the costs of administering the Zoning Ordinance and other regulatory Ordinances of the Township of Hopewell safeguarding persons and property.

SECTION 4. Any Ordinance or any provision of any Ordinance conflicting with the schedule of fees herein established is hereby repealed.

SECTION 5. This Ordinance shall be effective October 1, 1972.
