AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA VACATING AN UNNAMED 10-FOOT ALLEY ABUTTING LOTS NO. 59 AND 60 IN THE DAVIDSON HEIGHTS PLAN AND BEING WHOLLY SITUATE IN THE SAID TOWNSHIP OF HOPEWELL.

WHEREAS, the Board of Commissioners pursuant to notice as required by Section 2007 of The First Class Township Code, held a public hearing upon the petition of the sole owner of abutting property to vacate the 10-foot public alley hereinafter described; and

WHEREAS, as a result of said public hearing and in accordance with the mandate of Section 2008 of The First Class Township Code the Board of Commissioners has adopted a report recommending the vacation of said alley and has directed its Solicitor to file said report in the Office of the Clerk of Quarter Sessions of Beaver County, Pennsylvania; and

WHEREAS, for the reasons contained in said Report the Board of Commissioners has determined to vacate said alley;
