ORDINANCE NO. 73-11

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL,  
BEAVER COUNTY, PENNSYLVANIA,  
APPROVING AN AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF HOPEWELL TOWNSHIP AUTHORITY

WHEREAS, Hopewell Township Authority has determined that it was necessary to amend its Articles of Incorporation to extend its life in connection with the issuance of its Series of 1973 Bonds; and

WHEREAS, in order for said Amendment to become effective it must be approved by the Board of Commissioners of the Township of Hopewell.

NOW, THEREFORE, be it ordained and enacted by the Board of Commissioners of the Township of Hopewell, as follows:

1. The Articles of Amendment of the Township of Hopewell dated June 6, 1973, which read as follows:

"AMENDMENT OF ARTICLES OF INCORPORATION

OF

HOPEWELL TOWNSHIP AUTHORITY

To the Secretary of the Commonwealth  
Harrisburg, Pennsylvania

In compliance with the Municipality Authorities Act of 1945, May 2, P.L. 382, as amended, the Hopewell Township Authority hereby certifies:

(1) The name of the Authority is Hopewell Township Authority.

The location of the registered office of such Authority is Hopewell Township Municipal Building, Hopewell Township, Aliquippa, Beaver County, Pennsylvania.

(2) The Authority was formed under the terms of Act No. 164, approved May 2, 1945 (P.L. 382) as amended. The original Articles of Incorporation were recorded in the office of the Secretary

of the Commonwealth on May 16, 1946. Said original Articles of Incorporation were amended by an amendment approved and filed in the Department of State on the 5th day of May, A.D. 1958.

(3) The amendment to the Articles of Incorporation was adopted by the Board of Commissioners of the Township of Hopewell by Ordinance No. 73-11, enacted the 6th day of June, 1973, a certified copy whereof is attached hereto and made a part hereof.

(4) The amendment to the Articles of Incorporation adopted by the Board of Commissioners of the Township of Hopewell consists of a new provision to be added to the said Articles of Incorporation as follows:

"6th. The term of existence of the Authority is increased to a date fifty (50) years from the date of approval of these Articles of Amendment."
