AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING THE OFFICIAL ZONING MAP OF THE 1961 ZONING ORDINANCE OF HOPEWELL, TOWNSHIP.

WHEREAS, public notice of said hearing was given, as required by Section 609 of the Pennsylvania Municipalities Planning Code; and

WHEREAS, the within amendment has been submitted to the Hopewell Township Planning Commission and the Beaver County Planning Commission for advisory recommendation, as required by Section 609 of the Pennsylvania Municipalities Planning Code; and
