ORDINANCE NO. 43-4

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 58-9, EXHIBIT A, SECTION I, EXHIBIT A, SECTION II, SUB-PARAGRAPH A, BY PROVIDING FOR AN INCREASE OF SEWER SYSTEM CONNECTION CHARGES AND AN INCREASE IN SEWER RENTALS TO RESIDENTIAL USERS OF THE SANITARY SEWER SYSTEM.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Hopewell, Beaver County, Pennsylvania, and it is hereby Ordained and Enacted by authority of the same as follows:

SECTION 1. That portion of Hopewell Township Ordinance No. 58-9 Exhibit A, Section I. Sewer System Connection Charges, which in part reads as follows,

"Rates

For any type connection not itemized above, a connection charge shall be decided upon and fixed by the Township."

is hereby amended to read as follows:

- (a) Single family dwellings and single commercial establishments, each building sewer connection.....\$ 200.00
- (b) Trailers, mobile homes, each unit on building sewer connection.....\$ 200.00
- (c) Hotels, motels, multiple family dwellings, apartments and other multiple unit structures not subject to separate ownership, each unit on building sewer connection.....\$ 200.00
- (d) Shopping centers, condominiums, group of buildings, industrial park, office buildings and other multiple unit structures subject to separate ownership, each unit connection.....\$ 200.00
- (e) Churches, schools, fraternal organizations and governmental units, each building sewer connection.....\$ 200.00
- (f) Each eight inch connection.....\$ 400.00
- (g) Each ten inch connection.....\$ 800.00

For connections other than those listed above, a connection charge shall be determined by the Township and shall be payable at the same time as the connection charges listed above.

SECTION II. That portion of Hopewell Township Ordinance No. 58-9 Exhibit A, Section II. Sewer Rentals, which in part reads as follows,

"A. Residential

Private Dwelling, each..... \$14.00 per quarter"

be and the same is hereby amended to read as follows:

A. Residential

Each single family dwelling, dwelling in double house, in the row of connecting houses, apartment, house trailer, mobile home, motel room, hotel room, dormitory room, group of rooms, enclosure or other facility occupied or intended for occupancy as separate living quarters by a family or other group of persons living together or by persons living alone, each..... \$22.00 per quarter.

SECTION III. The provisions of this Ordinance shall become effective July 1, 1973.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Hopewell, Beaver County, Pennsylvania, and it is hereby Ordained and Enacted by authority of the same as follows:

SECTION I. That portion of Hopewell Township Ordinance No. 58-9 Exhibit A, Section I, Sewer System Connection Charges, which in part reads as follows,

"Rates

- (a) Each six (6) inch connection...\$ 75.00
- (b) Each eight (8) inch connection...150.00
- (c) Each ten (10) inch connection...350.00

For any type connection not itemized above, a connection charge shall be decided upon and fixed by the Township. It is hereby amended to read as follows:

- (a) Single family dwellings and single commercial establishments, each building sewer connection.....\$200.00
- (b) Trailers, mobile homes, each unit on building sewer connection.....\$200.00
- (c) Hotels, motels, multiple family dwellings, apartments and other multiple unit structures not subject to separate ownership, each unit on building sewer connection.....\$200.00
- (d) Shopping centers, condominiums, group of buildings, industrial park, office buildings and other multiple unit structures subject to separate ownership, each unit connection.....\$200.00

(e) Churches, schools, fraternal organizations and governmental units, each building sewer connection.....\$200.00

(f) Each eight inch connection.....\$400.00

(g) Each ten inch connection.....\$800.00

For connections other than those listed above, a connection charge shall be determined by the Township and shall be payable at the same time as the connection charges listed above.

SECTION II. That portion of Hopewell Township Ordinance No. 58-9 Exhibit A, Section II, Sewer Rentals, which in part reads as follows,

"A. Residential

Private Dwelling, each...\$14.00/quarter'
