ORDINANCE NO. 73-9

AN ORDINANCE OF HOPEWELL TOWNSHIP, BEAVER COUNTY, PENNSYLVANIA APPROVING THE CONSTRUCTION AND ESTIMATED PROJECT COST OF AN ADDITION TO THE RACCOON CREEK WATER POLLUTION CONTROL PLANT AND THE UPGRADING OF THE SAME, A PROJECT KNOWN AS THE "WEST DAVIDSON HEIGHTS SEWERAGE PROJECT" AND A PROJECT KNOWN AS THE "GOLF COURSE ROAD WATER LINE PROJECT."

WHEREAS, design drawings for an addition to the Raccoon Creek Water Pollution Control Plant as required by the Pennsylvania Department of Health, now Pennsylvania Department of Environmental Resources, have been prepared by Duncan, Lagnese and Associates, Inc., and have been presented by the Hopewell Township Authority to the Board of Commissioners of Hopewell Township, and

WHEREAS, design drawings for the construction of sanitary sewers in an area known as "West Davidson Heights" situate in said Township, have been prepared by Duncan, Lagnese and Associates, Inc., and have been presented by the Hopewell Township Authority to the Board of Commissioners of Hopewell Township, and

WHEREAS, design drawings for the construction of a water line known as the "Golf Course Road Water Line Project" to supply water to the Raccoon Creek Water Pollution Control Plant, have been prepared by Duncan, Lagnese and Associates, Inc. and have been presented by the Hopewell Township Authority to the Board of Commissioners of Hopewell Township, and

WHEREAS, approval of all of the above design drawings by the necessary Federal and State regulatory agencies has been or will be obtained and necessary permits will be obtained by said Board, and, said Board will record all of said permits in accordance with law, and

WHEREAS, said Municipal Authority, pursuant to an engineering report dated May 7, 1973 of Duncan, Lagnese and Associates, Inc.,

estimates that the total construction cost will be \$1,423,737.75, and

WHEREAS, the said Municipal Authority, pursuant to said financial report, estimates that the total project cost will be \$2,032,500.00, and

WHEREAS, the said Municipal Authority has received and accepted a Federal Grant under P.L. 660, in the amount of \$544,500.00 and a State Grant under the Land and Water Conservation Reclamation Act in the amount of \$198,000.00, or, total grants of \$742,500.00, and

WHEREAS, the Municipal Authority estimates that the total funds required, in addition to the total grants, is \$1,290,000.00, and

WHEREAS, the said Municipal Authority has requested the Commissioners of Hopewell Township to approve the total project cost of \$2,032,500.00.

NOW THEREFORE, be it Ordained and Enacted by the Commissioners of Hopewell Township, and it is hereby Ordained and Enacted by the authority of the same,

Section 1. The design drawings of Duncan, Lagnese and Associates, Inc. dated June of 1970 and bearing the title "Additions to the Raccoon Creek Water Pollution Control Plant" is hereby approved.

Section 2. The design drawings entitled "West Davidson Heights Sewerage Project" and "Golf Course Road Water Line Project" prepared by Duncan, Lagnese and Associates, Inc. dated October, 1972 and February, 1973, are hereby approved.

Section 3. The plan of construction for the said additions, extensions, and water line, as set forth in the report of Duncan, Lagnese and Associates, Inc. dated May 7, 1973 and bearing the legend "Financial Report, 1973 Sewerage Expansion Project", is hereby approved.

Section 4. The total estimated construction cost of \$1,423,737.75 as shown in said financial report, is hereby approved.

Section 5. The total project cost of \$2,032,500.00 as is shown in said financial report, is hereby approved.

Section 6. The total Bond Issue requirements, identified as Series "B" in said financial report in the amount of \$1,290,000.00, is hereby approved.

Section 7. Should any section or provision of this Ordinance be declared by any Court having jurisdiction to be invalid, the same shall not affect the validity of the Ordinance as a whole or any part thereof other than the part so declared to be invalid.

ORDAINED AND ENACTED finally into law by the Board of Township Commissioners this 6th day of June, 1973.
