ORDINANCE NO. 74-7

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING ARTICLE VI, SECTION 600-C OF ORDINANCE NO. 58-12, KNOWN AS HOPEWELL TOWNSHIP RULES AND REGULATIONS FOR THE SUBDIVISION OF LAND, BY DELETING PARAGRAPH (6) WHICH PROVIDED FOR WEDGE-TYPE ASPHALT CURBS AND SPECIFICATIONS.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

1. That Article VI, Section 600-C of Ordinance 58-12, known as Hopewell Township Rules and Regulations for the Subdivision of land shall be amended by fully deleting therefrom paragraph number (6) which reads as follows:

"(6) Wedge-type asphalt curb in accordance with specifications constituted herein and incorporated by reference hereto and on file for examination at the office of the Secretary of Hopewell Township, Hopewell Township Municipal Building, Clark Boulevard, Aliquippa, Pennsylvania.

2. All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed to the extent of such conflict.
