ORDINANCE NO. 75-1

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, THE 1961 ZONING ORDINANCE OF HOPEWELL TOWNSHIP AMENDING SAID ORDINANCE BY INCREASING THE FEE FOR FILING AN APPEAL FROM ACTION OF THE ZONING OFFICER AND INCREASING THE FEE ACCOMPANYING AN APPLICATION OR PETITION FOR ANY CHANGE OR AMENDMENT TO EXISTING ZONING DISTRICTS IN THE TOWNSHIP.

Now, therefore, BE IT ORDAINED by the Board of Commissioners of the Township of Hopewell, a municipal corporation under The First Class Township Code situate in the County of Beaver and Commonwealth of Pennsylvania, AND IT IS HEREBY ORDAINED:

1. That Subsection 2 of Section 1303 entitled "Procedure", of the 1961 Zoning Ordinance of Hopewell Township, which presently reads as follows:

"The appellant shall at the time of filing his appeal, pay the enforcing office a fee of Ten (\$10.00) Dollars to defray, or help defray, the cost of the required advertising."
is amended to read as follows:

"The appellant shall, at the time of filing his appeal, pay the enforcing office a fee of _______ Dollars

(\$_50.00 _____) to defray, or help defray, stenographic, advertising and other costs of said appeal."

2. That Section 1402 entitled "Application or Petitions", of said Zoning Ordinance which presents reads as follows:

"Applications or petitions for any change or amendments to existing zoning districts in the Township of Hopewell shall be made to the office of the Planning and Zoning Commission and shall be accompanied with a fee of twenty-five Dollars (\$25.00), payable to the Township Treasurer and shall be deposited in the General Fund. This fee is for the purpose of defraying the costs of preparing the necessary plats, maps, data, legislations, and notices and all official publications required by the Township and shall not be refundable even though the application is disapproved by the Board of Commissioners."

"Applications or petitioners for any change or amendments to existing zoning districts in the Township of Hopewell shall be made to the office of the Planning and Zoning Commission and shall be accompanied
