AN ORDINANCE TO ESTABLISH
THE TAX RATE
Notice is hereby given that the
Board of Commissioners of the Township of Hopewell will consider the
adoption of an ordinance fixing the
tax rate for the year 1978 and appropriating specific sums estimated
to be required for the specific purposes of the Township Government,
hereinafter set forth, for the 1978

fiscal year.
SECTION 1. That a tax be and the same is hereby levied on all property within the said Township subject to taxation for Township purposes for the fiscal year 1978 as follows:

Tax rate for general Township purposes, the sum of 8.7 mills on each dollar of assessed valuation, or the sum of eighty seven cents on each one hundred dollars of assessed valuation.

For debt purposes, the sum of 1.3 mills on each dollar of assessed valuation, or the sum of thirteen cents on each one hundred dollars of assessed valuation.

SECTION 2. That the amounts appropriated from the revenue available for the year 1978 for specific purposes are fully itemized in the Budget form.

SECTION 3. An estimate of the specific items making up the amounts appropriated to the respective Departments is on file in the office of the Manager/Secretary of the Township, Clark Boulevard and Circle Drive, Hopewell Township, Beaver County, Pennsylvania.
