AN AMENDMENT TO ORDENANCE NO .77-5 OF THE TOWNSHIP OF HOPEWELL. BEAVER COUNTY, PENNSYLVANIA, AMENDING SECTION 3 TO GIVE RESPONSIBILITY OF WRITTEN NOTICE TO OWNERS OR PERSONS IN CONTROL OF DOGS TO THE HOPEWELL TOWNSHIP POLICE DEPARTMENT REPLACING ZONING OFFICER OR SECRETARY.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Hopewell, a Municipal Corporation under the First Class Township Code situate in the County of Beaver and the Commonwealth of Pennsylvania, AND IT IS HEREBY ENACTED AND ORANINED:

3. That if any owner or person in control of a dog upon receiving Written Notice from the Hopewell Township Police Department that their dog is disturbing the peace and quiet of the neighborhood by repeatedly barking and fails to stop said disturbance within twenty-four (24) hours after receiving said notice, then said owner or person in control is in violation of this Ordinance.
