Beaver County, Pennsylvania and it is hereby ordained and enacted.


1. That the Hopewell Township Zoning Ordinance No. 79-1,  
Article XVII, Supplemental Regulations, Section 1708,  
C., is hereby amended to read as follows:

Section 1708 PRIVATE SWIMMING POOLS

- C. It may not be located closer than 10 feet to the rear  
property line nor closer to a side lot line than the  
required side yard depth of the principal use.
