AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA AMENDING ZONING ORDINANCE 79-1, ARTICLE XVII, SUPPLEMENTAL REGULATIONS.

A. Upon application for a building permit and zoning approval when such request involves the construction of Double Family and Multi-Family type dwelling units, excluding those proposals properly submitted under the Planned Residential Development Ordinance No. 76-2 or Hopewell Subdivision Ordinance No. 78-4, said plans shall be referred to the Township Planning Commission for review and Board of Commissioners for approval to assure proper site planning and proper future subdivision of the units.
