AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, TAKING OVER AND ADOPTING WASHINGTON STREET AND SCOTTSWOOD DRIVE, IN THE SCOTTSWOOD APARTMENTS PLAN IN THE TOWNSHIP OF HOPEWELL AS PUBLIC STREETS:

(b) Scottswood Drive, having a fifty (50) foot right of way and a twenty-four (24) foot cartway at existing grades beginning at Washington Street and terminating at a cul-de-sac, a distance of 881 linear feet.
