ORDINANCE NO. 83-1

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING SECTION 3 OF ORDINANCE NO. 60-2, AS AMENDED, WHICH PROVIDES FOR SEWER DISPOSAL, SETTING FORTH SPECIFICATIONS, TABLES, TESTS, RULES AND REGULATIONS FOR THE CONSTRUCTION AND MAINTENANCE OF SEPTIC TANKS, AND SEPTIC TANK SYSTEMS, PROVIDING FEES AND IMPOSING PENALTIES.

WHEREAS, it appears that the cost of inspection for septic tank permits, and permits issued in connection with septic tanks, has increased so as to place a burden on the General Fund of the Township of Hopewell;

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of Commissioners of the Township of Hopewell, and pursuant to the authority vested in said Board of Commissioners, under the First Class Township Code, that the permit fees for septic systems shall be as follows:

(a)	New Septic system	\$ 75.00
(ъ)	Repair to existing septic system for a residence	40.00
(c)	Re-connection from existing septic system	15.00
(d)	Permit issued on a lot in an approved subdivision whose pit and perc test have passed, to cover site inspection and final inspection.	40.00
(e)	Inspection fee for testing permits which are current and do not need a site inspection. (Decided at the discretion of the Sewage Enforcement Officer).	15.00

This fee schedule is for the purpose of revising the present fees set out in Section 3 of Ordinance 60-2 as amended. Said fees shall remain as listed above unless established differently by subsequent Ordinance.
