ORDINANCE NO. 83-2

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING THE ZONING MAP OF THE TOWNSHIP OF HOPEWELL FROM AN R-1 ZONING CLASSIFICATION TO AN R-2 ZONING CLASSIFICATION IN CONNECTION WITH PROPERTY OWNED BY THE WHITE OAKS DEVELOPMENT CORPORATION LOCATED ADJACENT TO PARKRIDGE DRIVE AND CRESTMONT DRIVE IN THE TOWNSHIP OF HOPEWELL.

WHEREAS, the White Oaks Development Corporation did make application to the Township of Hopewell requesting that certain property owned by them and located adjacent to Parkridge Drive and Crestmont Drive, be changed from an R-1 Zoning Classification to an R-2 Zoning Classification; and

WHEREAS, a public hearing pursuant to said request was held on July 28, 1983, at 7:30 P.M. at the Hopewell Township Municipal Building in accordance with the provisions of Ordinance No. 79-1, the Zoning Ordinance of the Township of Hopewell; and

WHEREAS, the Board of Commissioners of the Township of Hopewell, after having given the request due consideration and review, have determined that it would be in the best interests of the Township that the said Zoning Map Amendment be granted; and

WHEREAS, the specific parcel of property to be effected by said change is shown on an amended Zoning Map, which amended Zoning Map is marked Exhibit "A" and is attached hereto and made a part hereof.

BE IT ORDAINED AND ENACTED, by the Board of Commissioners of Hope-well Township, Beaver County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

Section I. That the Zoning Map of the Township of Hopewell is amended to change the existing Zoning Classification from R-1 to R-2 in


