AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, APPROPRIATING MONIES FROM MUNICIPAL TAXES AND REVENUES TO DEFRAY EXPENSES AND LIABILITIES OF THE TOWNSHIP OF HOPEWELL, FOR THE FISCAL YEAR COMMENCING JANUARY 1, 1986, AND ENDING DECEMBER 31, 1986.
