ORDINANCE # 85-8

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING SECTION 1 OF THE SEWER SERVICE CHARGE ORDINANCE #85-2

WHEREAS, the Hopewell Township Board of Commissioners is desirous of reducing the per thousand gallon charge for all Township sewer system customers; and

WHEREAS, the Consulting Engineer has recommended approval of said reduction;

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF HOPEWELL, and it is hereby ordained and enacted by authority of the same;

Exhibit "A" of Section 1 of Ordinance #85-2 is changed to read as follows:

Rates: A. Residential  
Rate Per 1,000 Gallons above  
a Quarterly Usage of 1,000 gallons. . . \$.80

- B. Non-Residential
1. All owners of non-residential property connected to the sewer system shall pay a sewer rental based upon actual water consumptions with exceptions as hereinafter noted. All sewer rentals based upon water consumption shall be computed using a Base Rate of \$25.00 per quarter per E.D.U. and a Usage Charge of \$.80 per 1,000 gallons.

The amendment shall take effect January 1, 1986.
