That the Hopewell Township Zoning Ordinance No 85-5
Article XVII, Supplemental Regulations, Section 1708,
c., is hereby amended to read as follows:

## Section 1708 PRIVATE SWIMMING POOLS

c. It may no be located closer than 10 feet to the rear property line nor closer to a side lot line than the required side yard depth of the principal use.
