ORDINANCE NO. 86-4

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL  
BEAVER COUNTY, PENNSYLVANIA, AMENDING  
ZONING ORDINANCE 85-5, ARTICLE XVII  
SUPPLEMENTAL REGULATIONS, SECTION 1708,C.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania and it is hereby ordained and enacted.

1. That the Hopewell Township Zoning Ordinance No 85-5 Article XVII, Supplemental Regulations, Section 1708, c., is hereby amended to read as follows:

Section 1708 PRIVATE SWIMMING POOLS

- c. It may no be located closer than 10 feet to the rear property line nor closer to a side lot line than the required side yard depth of the principal use.
