ORDINANCE NO. 86- 5

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING SECTION 1 OF ORDINANCE NOS. 60-2 AND 75-4, WHICH PROVIDES FOR SEWER DISPOSAL, SETTING FORTH SPECIFICATIONS, TABLES, TESTS, RULES AND REGULATIONS FOR THE CONSTRUCTION AND MAINTENANCE OF SEPTIC TANKS AND SEPTIC TANKS SYSTEMS, PROVIDING FOR FEES AND IMPOSING PENALTIES.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

SECTION 1. That Section 1 of Amending Ordinance No. 75-4 shall read as follows:

"Where such waste, sewage, feces, used water or other similar foul matter is directed or caused to flow into a septic tank, a permit shall be procured at the time of the installation of the same and a fee in the sum of Ninety (\$90.00) Dollars shall be paid to the Township Secretary at the time of making the application for the construction of the same."

ORDAINED AND ENACTED into an ordinance this 12 day of August, 1986.
