ORDINANCE NO. 86-8

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 69-2, AND ORDINANCE NO. 84-2, ESTABLISHING THE OFFICE OF TOWNSHIP MANAGER-SECRETARY IN SAID TOWNSHIP, PROVIDING FOR THE MANNER OF FILLING SAID OFFICE.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania, and it is hereby Ordained and Enacted by the authority of the same:

1. That Section 2 of said Ordinance No. 69-2 is hereby amended to read as follows:

Section 2. As soon as practicable after the enactment of this Ordinance, the Board of Commissioners shall elect by a majority vote of all it's members pursuant to resolution, one person to fill the office of Township Manager-Secretary to serve at the discretion of the Board of Commissioners.

2. That Section 5 of said Ordinance No. 84-2 is hereby amended to read as follows:

Section 5. The Township Manager-Secretary shall receive compensation in the amount of Twenty-nine Thousand Dollars (\$29,000.00) per year. Compensation may be modified from time to time by a majority vote of the Township Board of Commissioners pursuant to resolution.
