ORDINANCE NO. <u>\$8-5</u>, 1988

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, AMENDING THE TOWNSHIP ZONING ORDINANCE NO. 85-5

WHEREAS, the Beaver County Planning Commission by letter dated August 31, 1988, recommended that the Township Zoning Ordinance be amended to allow certain conditional use(s) in the R-1 Residential-Agricultural Zoning Classification; and

WHEREAS, the Hopewell Township Planning Commission at their regularly scheduled monthly meeting held on October 4, 1988, agreed with the recommendations put forth by the Beaver County Planning Commission and so advised the Township Board of Commissioners; and

WHEREAS, upon receiving the aforementioned Planning Commission recommendations, the Township Board of Commissioners have determined that the Township Zoning Ordinance should be amended as follows:

ARTICLE VI - R-1 Residential-Agricultural District, Section 601, Conditional Use, to include the following:

- C. Riding Academy
- D. Stable, Private
- E. Dog Kennel

ARTICLE III - Definitions, Section 301, to include the following:

RIDING ACADEMY: Any establishment where horses are kept for riding, driving, or stabling for compensation, or incidental to the operation of any club, association, ranch or similar establishment to be situated on parcels containing fifty acres or more.

STABLE, PRIVATE: Any accessory building in which horses are kept for riding, driving, stabling for private use, and not for hire or sale, to be situated on parcels containing fifty acres or more.

DOG KENNEL: As specifically defined by the "Pennsylvania Dog Law" 1982, Dec. 7, P.L. 784, No. 225, Art. I, Section 101 et seq. (3 P.S. 459-101, et seq.), to be situated on parcels containing fifty acres or more.
