AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY APPROPRIATING MONIES FROM MUNICIPAL TAXES AND REVENUES TO DEFRAY EXPENSES AND LIABILITIES OF THE TOWNSHIP FOR THE FISCAL YEAR ENDING DECEMBER 31, 1989.
