AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING THE ZONING MAP OF THE TOWNSHIP OF HOPEWELL FROM AN R-1 TO AN R-3 ZONING CLASSIFICATION IN CONNECTION WITH PROPERTY OWNED BY THE TOWNSHIP OF HOPEWELL LOCATED ON RHODE ISLAND EXTENSION SAID PROPERTY BEING DESIGNATED AS PLAYGROUNDS ON THE MEADOWOOD PLAN OF LOTS NUMBER 3, SECTION 2.

WHEREAS, The Township of Hopewell did make application to the Township of Hopewell requesting that certain property owned by them and located on Rhode Island Extension, being designated as Playgrounds on the Meadowood Plan of Lots Number 3, Section 2; and

Section I. That the Zoning Map of Hopewell is amended to change the existing Zoning Classification from R-1 to R-3 in connection with the parcel shown on Exhibit "A" that is attached hereto and made part hereof, and that is owned by the Township of Hopewell.

Section II. This Ordinance is enacted pursuant to authority granted to the Township of Hopewell in Ordinance Number 79-1, in the First Class Township Code and in the Municipalities Planning Code, as amended.




