## ORDINANCE NO. 89-10

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, APPROVING AND ADDPTING A PROPOSED AMENDMENT TO THE ARTICLES OF INCORPORATION OF CRESWELL HEIGHTS JOINT AUTHORITY, ALLEGHENY COUNTY, PENNSYLVANIA, TO INCREASE THE TERM OF EXISTENCE OF SAID AUTHORITY FOR A PERIOD EXPIRING FIFTY (50) YEARS FROM THE DATE OF APPROVAL OF SUCH AMENDMENT

WHEREAS, on January 3, 1950, the Secretary of the Commonwealth, of the Commonwealth of Pennsylvania, approved Articles of Incorporation of the CRESWELL HEIGHTS JOINT AUTHORITY, ALLEGHENY COUNTY, PENNSYLVANIA, and on the same date issued a certificate of the incorporation to said Authority pursuant to the provisions of the Municipal Authorities Act of May 2, 1945, P.L. 382, as amended; and

WHEREAS, said certificate of incorporation fixed the term of existence of said Authority at fifty (50) years which therefore provided for an expiration date of January 3, 2000; and

WHEREAS, on May 17, 1967, the Secretary of the Commonwealth issued a certificate authorizing an amendment to said Authority's Articles of Incorporation which provided that the Authority's existence would expire fifty (50) years from then (i.e. May 17, 2017); and

WHEREAS, at a regular meeting of the governing body of said Authority held on July 17, 1989, said Board adopted Resolution No. 89-11, a certified copy of which has been delivered to this governing body, reciting the necessity for said Authority to have its term of existence increased, proposing an amendment to its Articles of Incorporation and extending its terms of existence for a period of fifty (50) years from the date of approval of such amendment; and

WHEREAS, pursuant to Section 3.2 of the Municipality Authorities Act of 1945 as amended, 53 P.S. §305, such proposed amendment must be approved by the governing bodies of each of the municipalities composing said Authority.

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of the Township of Hopewell and it is hereby ORDAINED AND ENACTED by the authority of same:

SECTION 1. The Township of Hopewell, as one of the municipalities composing the Creswell Heights Joint Authority, Allegheny County, Pennsylvania, does hereby approve and adopt the proposal of the governing body of the Creswell Heights Joint Authority, as set forth in the Authority's Resolution No. 89-11, adopted July 17, 1989 that the Articles of Incorporation of said Authority be amended by adding the following Article thereto:

"(h) The term of existence of said Authority is hereby increased to expire on a date which shall be fifty (50) years from the date of approval of this Article of Amendment by the Secretary of the Commonwealth."

SECTION 2. The Secretary be and is hereby instructed to deliver to the Creswell Heights Joint Authority, Allegheny County, Pennsylvania, a duly certified copy of this Ordinance, and the proper officers of the Borough be and they are hereby authorized and directed to take any and all such further action as may be necessary or required to evidence the approval of said proposed amendment by the Township of Hopewell.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed insofar as they affect this Ordinance.
