ordinance 90-3

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, INCORPORATING GROUP HOMES OR ASSOCIATIONS OF RESIDENCES REPRESENTING SINGLE FAMILY DWELLING UNITS OR COMBINATIONS THEREOF INTO THE TOWNSHIPS EXCLUSIVE FRANCHISE FOR THE COLLECTION, HAULING, DISPOSAL AND BILLING OF GARBAGE, RUBBISH, BULKY WASTE AND RECYCLABLES FROM CERTAIN RESIDENCES IN THE MUNICIPALITY.

WHEREAS, the Township of Hopewell recognizes the need for an orderly and efficient garbage, rubbish, bulky waste and recyclable removal program and

WHEREAS, the Township passed Ordinance 90-2 allowing the exclusive franchise for the collection, hauling, disposal, and billing of garbage, rubbish, bulky waste and recyclables from certain residences in the Municipality, and

WHEREAS, specifications soliciting bids to award this exclusive franchise indicated the Townships desire to include single family residences represented by groups or associations within the scope of the municipally let contract, and

Whereas, the intention of the Township is to assure single family dwellings associated with their groups or association of residences be immediately incorporated within the scope of the Municipally let contract upon the expiration of existing contractural obligations or orher legal considerations prior to passage of Ordinance 90-2, and

WHEREAS, MT. Vernon Homes Tenant Association, Inc., and Independence Square Home Owners Association had entered into contractural obligations for the removal or garbage, rubbish, and other bulky waste,

WHEREAS, Independence Square has contractural obligations which expire on December 31, 1990

WHEREAS, Mt. Vernon Tenant Association Inc., has contractual obligations which will expire on November 30, 1991.

NOW THEREFORE, the Township of Hopewell, Beaver County, hereby ordains as follows:

SECTION 1. These single family residences shall fall within Ordinance 90-2 immediately upon expiration of their current contract as indicated above.

SECTION 2. For the purpose of this ordinance single family residences shall include a dwelling unit intended to accommodate a single family and having an exterior door with the ability to place their garbage, rubbish, bulky waste and recyclables at the curb. It shall not mean multi-family rental housing or apartment condominiums of four units or more, that do not contain individual exterior doors leading to a curb.

SECTION 3. This ordinance shall be deemed severable and if any part thereof be declared illegal, unconstitutional or void by any court, the remaining parts thereof shall continue in full force and effect.

SECTION 4. Any ordinance or part thereof conflicting with the provisions of this ordinance by and are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall be effective immediately upon passage
