ORDINANCE NO. 90- 84

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, ESTABLISHING THE COMPENSATION TO BE PAID THE TOWNSHIP COMMISSIONERS.

WHEREAS, the Commissioners of the Township of Hopewell are desirous of establishing the rate of compensation to be paid to any Township Commissioner beginning said Commissioner's next elected term of office; and

WHEREAS, said rate of compensation is set forth in the First Class Township Code, specifically section 703 pursuant to amendment enacted on October 31, 1985; and

WHEREAS, pursuant to said section the rate of compensation is directly proportional to the population of the Township of Hopewell; said population of Hopewell Township is presently plus or minus 14,000 persons; and

WHEREAS, the lawful rate of compensation pursuant to the First Class Township Code for elected Township Commissioners beginning their next elected term of office is Two-Hundred Dollars (\$200.00) per month or Twenty-Four Hundred Dollars (\$2,400.00) per annum;

BE IT ORDAINED by the Board of Commissioners of the TOWNSHIP OF HOPEWELL, a municipal corporation under The First Class Township Code and the legal authority contained therein and said Township being situate in the County of Beaver and Commonwealth of Pennsylvania, AND IT IS HEREBY ORDAINED:

1. The compensation to be paid to a Township of Hopewell Commissioner shall be the sum of Two-Hundred Dollars (\$200.00) per month or Twenty-Four Hundred Dollars (\$2,400.00) per year effective at the beginning of the next term of the elected officer. Said rate of compensation shall apply in any event to any appointed Township Commissioner.

Ordained and enacted into an Ordinance this 13 of November, 1990.
