ORDINANCE NO. 90-6

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA AND FIXING TAX RATES FOR THE 1990 CALENDAR YEAR AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR SPECIFIC PURPOSES OF THE TOWNSHIP GOVERNMENT.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Hopewell, Beaver County, a municipal corporation under the First Class Township Code of the Commonwealth of Pennsylvania.

SECTION 1. That on and during the 1991 calendar year a tax be and the same is hereby levied on all real property within the said Township of Hopewell subject to taxation for Township purposes.

The total tax rate for all Township purposes being the sum of seven point five mills on each dollar of assessed valuation, or the sum of seventy-five cents (\$.75) on each hundred dollars of assessed valuation.

SECTION 2. That collection period shall be two percent (2%) discount from March 1st through April 30th, face from May 1st through June 30th, ten percent (10%) penalty assessed after June 30th.


SECTION 3. That the estimated expenses of township government and the amounts appropriated therefore from the revenue estimated to be derived during the calendar year ending December 31, 1991 are fully set forth in the adopted budget of the Township, a copy of which is on file in the office of the Township Secretary, at the Township Municipal Building, Clark Boulevard, in the said Township of Hopewell and, the Pennsylvania Department of Community Affairs.

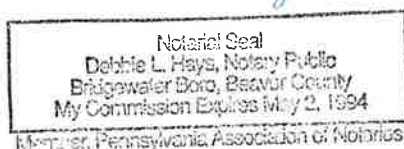
