ORDINANCE NO. 91-1

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL,
BEAVER COUNTY, PENNSYLVANIA

AMENDING CHAPTER 81, SECTION 12
OF THE FIRE PREVENTION ORDINANCE

BE IT ENACTED AND ORDAINED, by the Township of Hopewell, Beaver County, Pennsylvania and it is hereby enacted and ordained by the Authority of the same as follows:

Section I:

That Chapter 81, Section 12, is amended to add the following as a fire lane as follows:

§81-12 Enumeration

The following areas have been designated as fire lanes pursuant to this Article:

<u>Name of Street or Area</u>	<u>Designated Area</u>
Green Garden Shopping Center	As designated by signs and painted curbs
Hopewell Shopping Center	As designated by signs and painted curbs
Washington Street	Within Scotswood Development
Westfield Drive	Left side of street (odd numbered)

BE IT ORDAINED by the Board of Commissioners of the Township of Hopewell, a municipal corporation under The First Class Township Code and the legal authority contained therein and said Township being situate in the County of Beaver and Commonwealth of Pennsylvania, AND IT IS HEREBY ORDAINED:

1. That the following areas have been designated as fire lanes pursuant to this Article:

- a) Green Garden Shopping Center, as designated by signs and painted curbs;
- b) Hopewell Shopping Center, as designated by signs and painted curbs;
- c) Washington Street, within Scotswood Development;
- d) Westfield Drive, left side of street (odd numbered).

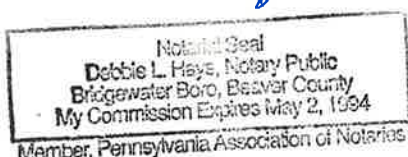
