ORDINANCE NO. 92-5

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA AMENDING THE TOWNSHIP ZONING ORDINANCE SECTION 156-21 NSD NEIGHBORHOOD SERVICE DISTRICT BY MAKING PROVISIONS FOR A CONDITIONAL USE.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania and it is hereby ordained and enacted.

- 1. That the Hopewell Township Zoning Ordinance Section 156-2 NSD Neighborhood Service District is amended by adding Subsection C which reads as follows:
- C. CONDITIONAL USE. Where the governing body has held a public hearing and been assured that the standards and criteria governing the granting of a conditional use (Article VI) have been met within the purpose and intent of this chapter and that no hazardous conditions will result, the following use shall be permitted:
 - 1. Restaurant, provided that said restaurant complies with the following requirements.
 - i) all requirements otherwise applicable to permitted uses in the neighborhood service district;
 - ii) all requirements of the Hopewell Township Zoning Ordinance; the Pennsylvania Municipalities Planning Code and any and all Township Ordinances that would relate to the operation of a restaurant facility;
 - iii) that applicable permits be obtained from the Pennsylvania Department of Transportation indicating Commonwealth approval of means of ingress or regress;

- iv) a buffer zone will be required in order to minimize the efforts of glare from headlights of vehicles, lights from structures, noise, movement of people and vehicles and to shield activities from adjacent properties. The type, location, width and height of the buffer zone shall be subject to the approval of the Board of Commissioners.
- v) that the restaurant facility shall not be open for business prior to 7:00 a.m. prevailing time on any day nor after 11:00 p.m. The business shall be closed and all patrons shall be off the premises by 12:00 midnight.
- vi) all deliveries to the facility shall be made during business hours as set forth in paragraph (v) above.
- viii) no exterior storage of material shall be permitted unless such storage is effectively screened from sight by trees, landscaped earth forms, fencing, walls, or some combination thereof, all of which is subject to approval by the Board of Commissioners.
- ix) the owners of said restaurant facility shall not permit the parking of vehicles on the premises except during regular business hours.
- x) any approved conditional restaurant use shall not be expanded, altered, modified, or otherwise changed without the approval of the Board of Commissioners.
- xi) no "drive through" windows of any kind shall be permitted on the premises.
