ORDINANCE NO. 93-2

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL,
BEAVER COUNTY, PENNSYLVANIA, AMENDING
ORDINANCE NO. 88-3 RELATING TO THE ADOPTION OF
SEWER SERVICE CHARGES AND REGULATIONS
PERTAINING TO SAME

WHEREAS, the consulting engineer of the township has recommended and the Township Board of Commissioners have unanimously agreed, that a revised schedule of connection charges be implemented with respect to the operation of the township sewer system;

NOW, THEREFORE, be and it is hereby ordained and enacted by the Board of Commissioners of the Township of Hopewell, and it is hereby ordained and enacted by authority of the same; Section 1. of Ordinance 88-3 is hereby amended to read as follows:

Section 1. The revised schedule of connection charges for the township sewer system as recommended by the Township's Engineer which are attached hereto as Exhibit A-1 and which are on file at the office of the Township Secretary are hereby adopted by the township. The remaining portions of Section 1, other than the schedule of connection charges for the sewer system, are retained in their entirety. This amended provision shall be incorporated into and shall amend Chapter 123, Article III Sec. 123-3 of the Township Code (codification of Township Ordinances)

EXHIBIT A-1

CONNECTION CHARGES AND SEWER RENTALS

(i) "Definitions:"

A. Connection Fee - Charge for Township to make connection from property line to main line.

B. Capacity Fee - Part of tapping fee associated with capacity cost for waste water treatment plants and interceptors in the Hopewell sanitary sewer system.

C. Collection Fee - Part of tapping fee associated with sewer collection system and pump stations.

D. Special Purpose Assessment - Part of the Tapping fee associated with the Municipal Water Authority of Aliquippa. Charge for the capacity costs to the Aliquippa system for those persons utilizing the Aliquippa treatment and interceptor system.

(ii) Fee Schedule Connections

I. Connections of less than 8"

Connection Fee	\$600.00
Capacity Fee	700.00
Collection Fee	800.00
Special Purpose Assessment	700.00

II. Connection of 8"

Connection Fee	\$1,000.00
Capacity Fee	1,170.00
Collection	1,330.00
Special Purpose Assessment	1,000.00

III. Connection of 10"

Connection Fee	\$1,880.00
Capacity Fee	2,220.00
Collection	2,500.00
