ORDINANCE NO. 94-8

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 88-3 AND 93-2 TO ADOPT THE WOODLAWN-SHEFFIELD TERRACE SEWER SERVICE DISTRICT AND IMPLEMENT SEWER SERVICE CHARGES AND REGULATIONS PERTAINING TO SAME.

WHEREAS, the Township Engineer has recommended and the Township Board of Commissioners has unanimously agreed, that a sewer service district known as the Woodlawn-Sheffield Terrace Sewer Service District shall be adopted, implementing a schedule of connection charges for that district, and incorporating definitions set forth in the Ordinance No. 93-2;

NOW THEREFORE, be it hereby ordained and enacted by the Board of Commissioners of the Township of Hopewell that Section 1. of Ordinance No. 88-3 shall be amended as follows:

A schedule of connection charges for the Woodlawn-Sheffield Terrace Sewer Service District as recommended by the Township Engineer which is attached hereto as Exhibit A-1 and which is on file at the office of Township Secretary is hereby adopted by the Township. The remaining portions of Section 1 of Ordinance No. 88-3 and Ordinance No. 93-2 are retained in their entirety. This amended provision shall be incorporated into and shall amend Chapter 123 Article III, Section 123-23 of the Township Code (codification of Township Ordinances)

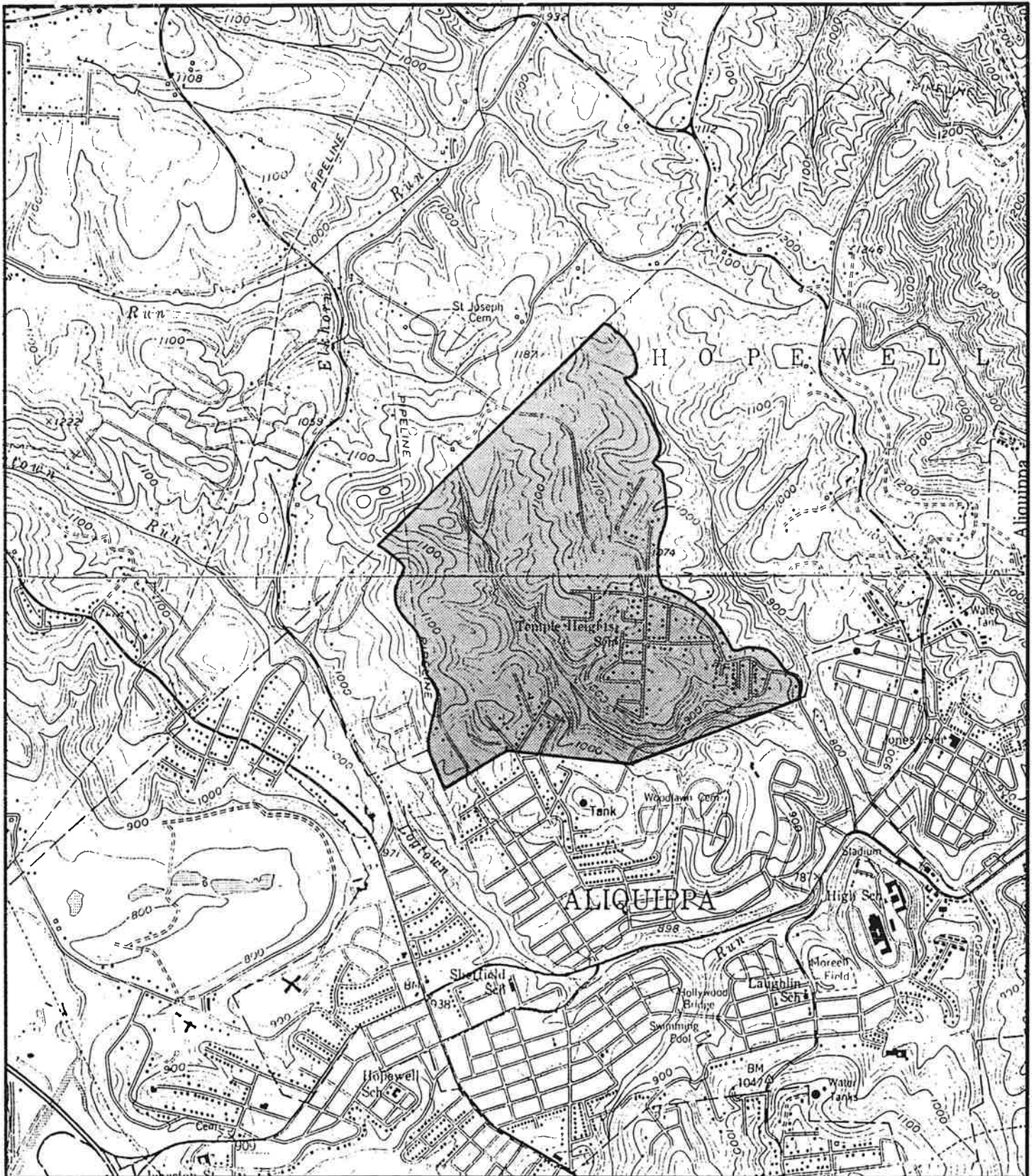
