ORDINANCE NO. 96 -2

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PA  
RENAMING CERTAIN STREETS LOCATED IN THE KANE HEIGHTS  
PLAN NO. 2

WHEREAS, the Board of Commissioner of the Township of Hopewell, Beaver County, Pennsylvania, A Township of the First Class, desires to officially rename the following streets located in the Kane Heights Plan No. 2:

"Woodland Drive" shall be "Forest Drive"

"Cherry Tree Place" shall be "Forest Drive"

"Pin Oak Court" shall be "Timber Lane;" and

WHEREAS, the above mentioned streets have already been commonly known and recognized as "Forest Drive" and "Timber Lane," but the Township takes this action to correct official records and documents; and

WHEREAS, the Township is statutorily authorized to make this street name change pursuant to Title 53 Section 56522 Pa. C.S.A.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Township of Hopewell, a municipal corporation under the First Class Township Code, situate in the County of Beaver and Commonwealth of Pennsylvania, and IT IS HEREBY ORDAINED

(1) That pursuant to the authority contained in the First Class Township Code, the following streets located in the Kane Heights Plan No. 2 shall be renamed as followed:

"Woodland Drive" shall be "Forest Drive"


"Cherry Tree Place" shall be "Forest Drive"
