ORDINANCE 96-7

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 82-6, AUTHORIZING THE PLACEMENT OF STOP SIGNS ON VARIOUS TOWNSHIP STREETS AND ROADWAYS AND PROVIDING PENALTIES FOR VIOLATIONS OF THE SAME.

WHEREAS, the Board of Commissioners of the Township of Hopewell has determined that it is necessary to authorize the placement of stop signs on certain township streets and roadways so that traffic may be better controlled and so that the streets and roadways are safe for both vehicles, bicycles, and pedestrian traffic.

NOW THEREFORE BE IT ORDAINED AND ENACTED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

Section 1. Whenever a stop sign confronts the driver of any vehicle or the operative rider of any motorcycle, moped, or bicycle, such driver shall obey the indication of such stop sign on those streets and roadways which are designated in Exhibit "A", attached hereto.

Section 2. The driver of a vehicle shall stop in obedience to a stop-sign at an intersection where a stop sign is erected at one or more entrances thereto, and shall proceed cautiously yielding to the vehicles not so obliged to stop which are within the intersection or approaching so close as to constitute an immediate hazard, unless traffic at such intersection is controlled by a police officer on duty, in which event the directions of the police officer shall be complied with. The stop sign shall be red in color and in the shape of an octagon.

Section 3. No person shall place, maintain or display upon or in view of any highway any unauthorized sign, signal, marking or device which purports to be or is in imitation of or resembles an official traffic control device or railroad sign or signal, or which attempts to direct the movement of traffic, nor shall any person place, maintain or display upon or in view of any highway any other sing which hides traffic control devices from view or interferes with the movement of traffic or the effectiveness of any traffic-control device of any railroad sign or signal, and no person shall place or maintain nor shall any public authority permit upon any highway any traffic or signal bearing thereon any commercial advertising.

Section 4. It shall be unlawful for any person to deface, injure, move or interfere with any official traffic control sign or signal.

Section 5. Every person convicted of violation of this Ordinance shall be sentenced to pay a fine of \$25.00 plus the costs of prosecution.

Section 6. This Ordinance is enacted pursuant to 75 P.S. 6102(b) and 75 P.S. 6109(1).

Section 7. Exhibit "A" attached hereto, may be amended by Resolution from time to time when the Township deems necessary.

RESOLUTION NO. 2009-15

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, A FIRST CLASS TOWNSHIP UNDER THE LAWS OF THE COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING A POLICY PURSUANT TO ORDINANCE 96-7 FOR THE PLACEMENT OF STOP SIGNS ON VARIOUS TOWNSHIP STREETS AND ROADWAYS

WHEREAS, the Township of Hopewell adopted Ordinance No. 96-7, and prior thereto Ordinance No. 82-6, to authorize the placement of stop signs on various Township streets and roadways to ensure the safety and welfare of motorists and pedestrians; and

WHEREAS, stop signs are a common traffic control device intended to assign the rightof-way at intersecting street locations and are not to be used to control speed as studies have shown that this only causes a brief interruption or reduction of speed followed by an immediate acceleration between stop signs to make up for a motorist's perceived lost time; and

WHEREAS, the Pennsylvania Department of Transportation adopted (at 67 Pennsylvania Code Chapters 201, 203, 204, 211, 212 and 217) the National Manual on Uniform Traffic Control Devices (MUTCD) as published by the Federal Highway Administration (FHWA) setting forth standards for traffic control in the Commonwealth of Pennsylvania including additional study requirements, warrants, principles and guidelines; and

WHEREAS, certain amendments to Title 67 of the Pennsylvania Code (Publication 212) establish greater uniformity for the design, location and operation of all official traffic signs, signals, markings and other traffic-control devices within the Commonwealth of Pennsylvania; and

WHEREAS, in order to properly place, revise or remove a stop sign in accordance with the above-referenced code provisions and regulations, sufficient data regarding vehicular volume counts, sight distance measurements, delay estimates, intersection geometry, adjacent roadway features, vehicle speeds and historical accident reporting must be obtained and evaluated; and

WHEREAS, it is the desire of the Board of Commissioners of Hopewell Township and the purpose of this Resolution to incorporate uniform procedures to be followed when placing or removing a stop sign in accordance with the amendments to Title 67 of the Pennsylvania Code and the MUTCD in order to ensure public safety by reducing accidents and properly regulating traffic through the Township of Hopewell.

AND NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF HOPEWELL THIS 4th DAY OF June 2009:

- Stop signs hereafter erected upon, revised or removed from the streets or roads of 1. Hopewell Township, shall (in accordance with Chapter 67 of the Pennsylvania Code Publication 212, Chapter 75 of the Pennsylvania Consolidated Statutes and the MUTCD) be subject to an engineering and traffic study by the Township which study shall entail an orderly examination or analysis of physical features and traffic conditions on or along a highway, conducted in accordance with the aforementioned provisions, for the purpose of ascertaining the need or lack of need for a stop sign at the subject location.
- Engineering and traffic studies will be performed by a Public Safety Committee 2. comprised of the Chief or Assistant Chief of Police, Township Manager or his designee, Road Foreman, Township Engineer or his designee and one resident citizen of the Township as appointed by the Board of Commissioners.
- A warrant is a description of the threshold conditions to be used in evaluating the 3. potential safety and operational benefits of a stop sign based upon average or normal conditions.
- The establishment or revision of a stop sign may be justified if one of the following 4. applies:

a. One or more of the engineering and traffic study warrants justifies the

establishment or revision of a stop sign.

b. Sound engineering judgment based upon a combination of all data sources substantiates the need for the restriction.

- The removal of a stop sign may be justified if one of the following applies: 5.
 - a. A study indicates that no engineering or traffic study warrant justifies the existing stop sign.
 - b. The condition that originally justified the stop sign no longer exists.
- Warrants provide the threshold for consideration of the installation, revision or 6. removal of a stop sign, but are not a substitute for engineering judgment.
- The warrants to be applied by the Public Safety Committee when installing, revising 7. or removing a stop sign shall be those set forth in the Pennsylvania Department of Transportation's Publication 212, as amended from time to time. A copy of the current version is attached hereto as Exhibit "A."
- The policy adopted by this Resolution shall become effective immediately upon 8. adoption hereof and shall remain in effect unless or until modified or changed by further Resolution of the Township.

WHEREAS, the Hopewell Township Board of Commissioners deem it necessary upon the recommendation of the Hopewell Township Chief of Police, to amend Exhibit A of Ordinance 96-07, by adding the following stop signs to the street list: School Street, one sign, (Eastbound, on the South-East corner) as it intersects at the 90 degree continuance of School Street Eastbound; Knoll Street, one sign (Southbound, on South-West corner) at the intersection of Longvue Avenue; Knoll Street, one sign (Northbound, South-East corner) at the intersection of Euclid Avenue; Fisk Street, one sign (Northbound, South-East corner) at the intersection of Euclid Avenue; Perry Street, one sign (Northbound, South-East corner) at the intersection of Euclid Avenue; Longvue Avenue, one sign (Eastbound, on South-West corner) at the intersection of Washington Street; Goodnow Street, one sign (Eastbound, South-West corner) at the intersection of McIntosh Drive; McIntosh Drive, two signs (Northbound, South-East corner and Southbound, North-West corner) at the intersection of Goodnow Street.



AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 82-6, AUTHORIZING THE PLACEMENT OF STOP SIGNS ON VARIOUS TOWNSHIP STREETS AND ROADWAYS AND PROVIDING PENALTIES FOR VIOLATIONS OF THE SAME.

WHEREAS, the Board of Commissioners of the Township of Hopewell has determined that it is necessary to authorize the placement of stop signs on certain township streets and roadways so that traffic may be better controlled and so that the streets and roadways are safe for both vehicles, bicycles, and pedestrian traffic.

NOW THEREFORE BE IT ORDAINED AND ENACTED by the Board of Commissioners of Hopewell Township, Beaver County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

Section 1. Whenever a stop sign confronts the driver of any vehicle or the operative rider of any motorcycle, moped, or bicycle, such driver shall obey the indication of such stop sign on those streets and roadways which are designated in Exhibit "A", attached hereto.

Section 2. The driver of a vehicle shall stop in obedience to a stop-sign at an intersection where a stop sign is erected at one or more entrances thereto, and shall proceed cautiously yielding to the vehicles not so obliged to stop which are within the intersection or approaching so close as to constitute an immediate hazard, unless traffic at such intersection is controlled by a police officer on duty, in which event the directions of the police officer shall be complied with. The stop sign shall be red in color and in the shape of an octagon.



Section 3. No person shall place, maintain or display upon or in view of any highway any unauthorized sign, signal, marking or device which purports to be or is in imitation of or resembles an official traffic control device or railroad sign or signal, or which attempts to direct the movement of traffic, nor shall any person place, maintain or display upon or in view of any highway any other sing which hides traffic control devices from view or interferes with the movement of traffic or the effectiveness of any traffic-control device of any railroad sign or signal, and no person shall place or maintain nor shall any public authority permit upon any highway any traffic or signal bearing thereon any commercial advertising.

Section 4. It shall be unlawful for any person to deface, injure, move or interfere with any official traffic control sign or signal.

Section 5. Every person convicted of violation of this Ordinance shall be sentenced to pay a fine of \$25.00 plus the costs of prosecution.

Section 6. This Ordinance is enacted pursuant to 75 P.S. 6102(b) and 75 P.S. 6109(1).

Section 7. Exhibit "A" attached hereto, may be amended by Resolution from time to time when the Township deems necessary.
