## **ORDINANCE 96-** 9

AN ORDINANCE OF HOPEWELL TOWNSHIP, , BEAVER COUNTY, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING MEMBERSHIP IN THE NONPROFIT CORPORATION DESIGNATED AS THE MID-BEAVER VALLEY COUNCIL OF GOVERNMENTS, INC.

WHEREAS, Hopewell Township, Beaver County, Commonwealth of Pennsylvania, desires to join with the other participating members in a Pennsylvania Nonprofit Corporation known as the Mid-Beaver Valley Council of Governments in order to have a legal entity for the purpose of fostering intermunicipal cooperation in solving problems, forming policies, and making plans that are common and regional:

**NOW, THEREFORE, IT IS ORDAINED** by the Board of Commissioners, Hopewell Township, Beaver County, Commonwealth of Pennsylvania as follows:

- 1. In accordance with the provisions of Act No. 180 of 1972, 53 P.S. 481, et seq., Hopewell Township, Beaver County hereby joins with the other participating members in the Pennsylvania Nonprofit Corporation known as the Mid-Beaver Valley Council of Governments, Inc.
- 2. The purpose of the Corporation has been set forth in the Articles of Incorporation of the Mid-Beaver Valley Council of Governments and includes:
  - a. Identification, discussion and study of regional issues and development opportunities.
  - b. Promotion of effective communication and coordination among member governments and their agencies.
  - c. Cultivation and development of coordinated plans and policies for regional development and resource conservation.
  - d. Facilitation of agreements among member governments to cooperatively undertake specific projects.
  - e. Service as the regional spokesman on matters of state or national interest.
  - f. Assistance to member governments as they direct.
  - g. Review and coordination of Federal, State, and Local programs ass directed by member governments.
  - h. Entrance into grant agreements with Federal State, or private agencies to carry out projects desired by the members.
- 3. The Corporation is to exist in perpetuity, but municipalities may join and withdraw from the Corporation at any time in the manner set forth in the bylaws of the Mid-Beaver Valley Council of Governments.

- 4. The Mid-Beaver Valley Council of Governments, Inc. shall be financed by annual dues and fees paid by member municipalities and by funds obtained by the Corporation from public or private sources.
- 5. The organizational structure of the Corporation shall be as set forth in the bylaws of the Mid-Beaver Valley Council of Governments.
- 6. No action taken by the Mid-Beaver Valley Council of Governments, which creates a legal obligation, whether it be contractual, financial, or otherwise, upon a member municipality shall be binding upon the municipality unless and until its legislative body ordains, resolves or otherwise so approves.
