**ORDINANCE 96-15**

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL,  
BEAVER COUNTY, PENNSYLVANIA, APPROPRIATING  
MONIES FROM MUNICIPAL TAXES AND REVENUES TO  
DEFRAY EXPENSES AND LIABILITIES OF THE  
TOWNSHIP FOR THE FISCAL YEAR ENDING DECEMBER  
31, 1997.

BE IT ORDAINED AND ENACTED, and it is hereby  
ordained and enacted by the Board of Commissioners of the  
Township of Hopewell, Beaver County Pennsylvania, and it is hereby  
ordained and enacted according to the power and authority granted  
under the First Class Township Code, Act of December 14, 1967, P.L.  
819, effective January 1, 1969;


SECTION 1. That the following sums of money, or as much thereof

ending on the thirty-first day of December 1997.

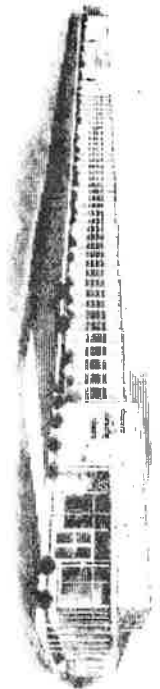

RE-APPROPRIATING THE BUDGET

**ORDINANCE 96-15**  
AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY PENNSYLVANIA, FIXING TAX RATES FOR THE 1997 CALENDAR YEAR AND APPROPRIATING SPECIFIC FUNDS ESTIMATED TO BE REQUIRED FOR THE FISCAL YEAR ENDING DECEMBER 31, 1997.  
BE IT ORDAINED AND ENACTED that it is hereby ordained and enacted by the Board of Commissioners of the Township of Hopewell, Beaver County Pennsylvania, and it is hereby ordained and enacted according to the power and authority granted under the First Class Township Code, Act of December 14, 1967 P.L. 819, effective January 1, 1969:

**SECTION 1.** That the following sums of money, or as much thereof as may be authorized by law, as may be needed or deemed necessary to defray all expenses and liabilities of the Township, be and the same hereby appropriated for the purposes and objects of said Township hereinafter specified for fiscal year commencing on the first day of January 1997 and ending on the thirty first day of December 1997.

Sewer System	1,500,000
Sewer Construction	300,000
State Liquor Fees	200,000

**SECTION 2.** That collection period shall be two (2%) discount from March 1st through April 30th, face from May 1st through June 30th, ten percent (10%) penalty assessed after June 30th.
