## ORDINANCE 97-2

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, INCREASING THE SALARY OF THE TOWNSHIP TREASURER FROM \$4,500.00 ANNUALLY TO \$6,000.00 ANNUALLY AS COMPENSATION FOR THE COLLECTION OF TAXES

WHEREAS, The Board of Commissioners of the Township of Hopewell are authorized, pursuant to the First Class Township Code, Title 53 P.S. section 55603, to set the salary of the elected officers of the Township; and

WHEREAS, The Board of Commissioners of the Township of Hopewell are authorized, pursuant to The Local Tax Collection Law, Title 72 P.S. section 5511.34, to compensate the Township Treasurer for tax collection duties at a sum equal to five per cent of all township taxes received or collected and, in addition, a sum equal to one per cent on all other moneys received or collected unless a different rate or annual compensation shall be fixed by ordinance of the Township Commissioners, provided that in no case shall the total compensation exceed \$10,000.00; and

WHEREAS, The Board of Commissioners of the Township of Hopewell now desire to increase the annual rate of compensation of the Township Treasurer from \$4,500.00 to \$6,000.00.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Township of Hopewell, a municipal corporation under the First Class Township Code, situate in the County of Beaver and Commonwealth of Pennsylvania, AND IT IS HEREBY ORDAINED:

- 1) That pursuant to the authority contained in the First Class Township Code and The Local Tax Collection Law, the Board of Commissioners of the Township of Hopewell hereby increase the annual compensation of the Township Treasurer from \$4,500.00 to \$6,000.00; and
- 2) In addition, the Township Treasurer, as tax collector, shall be allowed such actual printing and postage expenses as shall be incurred in performing collection duties; and
- 3) This change in compensation in the office of the Township Treasurer shall become effective at the beginning of the next term of the elected Treasurer.
