SECTION 2. That collection period shall be two percent (2%) discount from March first through April thirtieth, face from May first through June thirtieth, ten percent (10%) penalty assessed after June thirtieth.

That the estimated expenses of Township government and the amounts appropriated therefore from the revenue estimated to be derived during the calendar year ending December thirty-first, 1999, are fully set forth in the adopted budget of the Township, a copy of which is on file in the office of the Township Secretary, at the Township Municipal Building, 1700 Clark Boulevard, Aliquippa, Pennsylvania, and the Pennsylvania Department of Community Affairs.
