ORDINANCE 2004-13

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, FIXING TAX RATES FOR THE 2005 CALENDAR YEAR AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR SPECIFIC PURPOSES OF THE TO TOWNSHIP GOVERNMENT.

BE IT ORDAINED AND ENACTED, by the Board of Commissioners of the Township of Hopewell, Beaver County, a Municipal Corporation under the First Class Township Code of the Commonwealth of Pennsylvania.

SECTION 1. That for and during the 2005 calendar year, a tax be and is hereby levied on all property within said Township of Hopewell, subject to taxation for Township purposes.

The total tax rate for all Township purposes being the sum of ELEVEN mills of each dollar of assessed, or the sum of one dollar and ten cents \$1.10 on each hundred dollars of assessed valuation.

SECTION 2. That collection period shall be two percent (2%) Discount from March first through April thirtieth; Face, from May first through June thirtieth, and ten percent (10%) Penalty assessed after June thirtieth.

SECTION 3. That the estimated expenses of Township government and the amounts appropriated therefore from the revenue estimated to be derived during the calendar year ending December thirty-first, 2005 are full set forth in the adopted budget of the Township, a copy of which is on file in the office of the Township Manger, at the Municipal Building, 1700 Clark Boulevard, Aliquippa, PA.
