**HOPEWELL TOWNSHIP  
ORDINANCE NO. 2005-03**

**AN ORDINANCE OF HOPEWELL TOWNSHIP, BEAVER  
COUNTY, PENNSYLVANIA, INCREASING ITS TREASURER'S  
ANNUAL SALARY FROM \$7,440.00 TO \$10,000.00 AS  
COMPENSATION FOR THE COLLECTION OF TAXES**

**WHEREAS**, the Hopewell Township Board of Commissioners is authorized under the First-Class Township Code, 53 P.S. § 55603, to set the salary/compensation of its elected officers; and,

**WHEREAS**, the Hopewell Township Board of Commissioners is authorized under the Local Tax Collection Law, 72 P.S. § 5511.34, to compensate its Treasurer to collect taxes at a sum equal to five (5%) percent of all Township taxes received or collected and, in addition, a sum equal to one (1%) percent on all other moneys received or collected unless a different rate or annual compensation shall be fixed by ordinance, provided that in no case shall the total compensation exceed \$10,000.00

**NOW, THEREFORE, BE IT ORDAINED** by the Township of Hopewell, Beaver County, Pennsylvania, effective as of January 1, 2006:

1. The annual salary/compensation of the Hopewell Township Treasurer is increased from \$7,440.00 to \$10,000.00;
2. The Township Treasurer, as Tax Collector, shall be permitted such printing and postage expenses which are necessary to perform the duties of tax collection; and,
3. This increase in the Township Treasurer's salary/compensation shall become effective at the beginning of the next term of the elected Treasurer, January 1, 2006.

**ORDAINED AND ENACTED** into an ordinance this 29th day of December, 2005.


