**ORDINANCE 2005 08**

**AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA  
APPROPRIATING MONEYS FROM MUNICIPAL TAXES AND REVENUES TO DEFRAY  
EXPENSES AND LIABILITIES OF HOPEWELL TOWNSHIP FOR THE FISCAL YEAR  
ENDING DECEMBER 31, 2006.**

**BE IT ORDAINED AND ENACTED**, and it is hereby ordained and enacted by the Board of Commissioners of the Township of Hopewell, Beaver County, Pennsylvania, and it is hereby ordained and enacted according to the power and authority granted under the First Class Township Code, Act of December 14, 1967, P.L. 819, effective January 1, 1969.

SECTION 1. That the following sums of money, or as much therefore as may be authorized by law, as may needed or deemed necessary to defray all expenses and liabilities of the Township, be and the same hereby appropriated for the purposes and objects of said Township hereinafter specified for fiscal year commencing on the first day of January 2006 and ending the thirty-first day of December 2006.
