## ORDINANCE 2007-07

AN ORDINANCE OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA APPROPRIATING MONEYS FROM MUNICIPAL TAXES AND REVENUES TO DEFRAY EXPENSES AND LIABILITIES OF HOPEWELL TOWNSHIP FOR THE FISCAL YEAR ENDING DECEMBER 31, 2008.
